## Abstract

This data set contains data and measures of blood lead testing results for Children born in the same year and tested at least once before their third birthday. These measures use data collected by state and local childhood lead poisoning prevention programs.

## Purpose

This data set is intended to calculate the number of elevated childhood blood lead levels by birth cohort for use on the Iowa Public Health Tracking Portal, consistent with the guidance for creating Nationally Consistent Data and Measures (NCDMs).

## Supplementary Information

The Under 3 Cohort for 2010 represents all children with a birth year of 2010, and includes all blood lead tests conducted on those children before their 3rd birthday. So it includes all test data from 01/01/2010 through 12/31/2013. This dataset reflects updates to the NCDMs to classify children with blood lead levels between 5 and less than 10 mcg/dL. This dataset contains confidential information. Small numbers suppression has been applied to data available on the public portal.
